Norwegian Business Association Korea – By the Business, For the Business

The Norwegian Business Association Korea is a non-profit, member-based association for Norwegian companies and business people in the Republic of Korea. The association was established in 2002 on the initiative of the Norwegian ambassador, and the Royal Norwegian Embassy continues to support the activities of the association. NBA Korea aims to be a natural contact point for Norwegian companies entering Korea, with membership open to both organisations and individuals.

Lead by a board elected from the members, NBA Korea's objective is to provide fora where topics of mutual interest are presented and discussed, providing opportunities for business networking and socialising among members. The association acts as a representative voice for Norwegian companies in Korea through its role as a sounding board towards Team Norway. NBA Korea also cooperates with other appropriate bodies to further support the objectives.

The current membership of the association is multi-national, with representation from various industries.

There are four membership categories:

Company Membership

This is open to all companies and branch/representative offices of Norwegian companies, in which there is a direct Norwegian interest. Typically subsidiaries, joint ventures, agents etc. Membership fee: KRW 220,000 per annum

Individual Membership

This is open to employees of companies that are company members. Membership fee: KRW 66,000 per annum

Special Membership

This is open to Norwegian citizens resident in Korea, or other individuals who are engaged in business or profession in Korea but whose company cannot qualify for company membership. Typically Norwegians working for Korean or other non-Norwegian companies or Koreans with special interest in the Korea-Norway relationship. Not entitled to hold office and vote. Membership fee: KRW 33,000 per annum.

Honorary Membership

This is open to any person, partnership, corporation or other entity that cannot qualify for the above membership categories but that has made a distinguished contribution in furthering the purpose of the Norwegian Business Association in Korea is eligible to become an honorary member. The Association shall have the power to offer honorary membership. Not entitled to hold office and vote. Membership fee: KRW 33,000 per annum.
